2. Guest Presentation: "Survivors Speaking on Marin Responses to Domestic Violence"

- Three members of Voces de Cambio, a group of Marin County DV survivors now working to increase community awareness, discussed their experiences seeking help from various Marin County agencies while exiting abusive relationships.
- 3. Special Presentation: "Is Your Relationship Affecting the Children?"
 - C4DP presented a new assessment tool for parents who are worried about the effects of their unhealthy relationship on their children. Additionally, 10 family and children's service agencies were welcomed to the CCR as it expands to include a new focus area, Children Exposed to Domestic Violence. Three meetings will be held to build the ability of those orgs to assist children exposed to DV, and to identify and fill gaps in service for this vulnerable population in Marin. Cards were distributed at the meeting and will be available to Marin County service providers for distribution at their offices in English and Spanish. - 4. Strategic Directions Updates
 - Preventing Future Abuse: The Marin Against Youth Abuse liaisons showed the Advocacy Campaign they designed and implemented in the last period. The campaign featured bus ads and movie theater spots that played before the trailers at Marin County cinemas. The MAYA liaisons guided the design of the ads and were featured in the images.
 - 2) Data and Evaluating Our Progress:
 - i. LE DV Liaison Data Project: Most Marin County PD departments are creating methods to track officer compliance with the Marin County Police Response to DV at-a-glance "Pocket Card", which summarizes the uniform LE responses required in the Marin County LE Policy over a three year period that includes reports before and after officer training. Mill Valley PD presented their results after one year of pocket card use.
 - ii. Victim Feedback Survey: Felice McClenon, Marin County Health and Human Services, gave an overview of a victim feedback survey the CCR Data Committee is creating for CCR partners to distribute to their participants with the goal of identifying gaps in service and strengthening our response and referral network.
- 5. Law Enforcement Trend Report July through December 2016
 - Marin County Sheriff
 - 22 Felony and 21 Misdemeanor cases
 - Dominant aggressor determined and/or arrest made
 - Novato
 - 23 Felony and 30 Misdemeanor cases
 - Dominant aggressor determined and/or arrest made
 - Officers have been using the Pocket Card since 2014
 - Central Marin
 - 7 Felony and 14 Misdemeanor cases
 - Dominant aggressor determined
 - Officers received Pocket Cards this month and will be completing the Pocket Card training over the next few weeks
 - San Rafael
 - 55 Felony and 40 Misdemeanor cases, 24 RO violations
 - Mill Valley
 - 2 Felony and 3 Misdemeanor cases
 - Dominant aggressor determined
 - The most effective strategies for increasing victim safety are separating parties immediately, using the Pocket Card steps and focusing on risk assessment at scene with victim. Hotline connections were made and/or EPOs are obtained for all victims.
- 6. District Attorney Trend Report
 - 50 Felonies and 91 Misdemeanor cases were filed and convictions were made in 44 Felonies and 49 Misdemeanors. The improvement is due to increased communication between LE Liaisons, C4DP advocates, and DA Office.

- Fundamental changes will be made in Marin County Family Court, transitioning to an accountability court in 2017. Additionally, court now has a protocol for judges to speak individually with victims who say they want to take the 5th and direct them to C4DP for information on that course of action.
